4. Communications Update (Kathleen)

a. Updates on checklists for content sharing on newsletter and social media platforms. There are two checklists, one for board members and non-board members. The program should be what it needs to be for mentors and mentees. Erin Branigan suggested evaluating the mentorship program using Survey Monkey or a similar platform to get feedback.

b. Brad brought up a restructuring of the board. Consistent challenges the board faces are frequent board member turnover, not well-defined positions and general recruitment is difficult. One recommendation was to formalize committees as the primary working unit of the board.

NPCA 2020 Review:

- NPCA transitioned from the office to working from home in March
- Quickly pivoted to provide programs and support for the 7,300 Volunteers evacuated from all over the world. With two dedicated staff members

• Set a record in 2020 for the number of RPCV Membership, Advocacy, Outreach and Fund Raising.

• Increased NPCA's visibility and sustainability

• Held 8 "Virtual Summits" on different subject to gather information from hundreds of participating RPCVs and several speakers from countries served by Peace Corps to gather information and ideas for PC's future, which resulted in the report: "Peace Corps Connect to the Future". NPCA Goals for 2021:

• Will occupy their new "Peace Corps Place" office, near the relocated Peace Corps Headquarters in May or June of 2021

• Has submitted a bid with a contractor for the acquisition and redevelopment of the Historical Slater and Langston school buildings next to Peace Corps Place. If their bid is accepted by the City of Washington, DC, from the several bids submitted, NPCA will open the Peace Corps Museum and community space on the first floor of the redeveloped schools and have office space on the second floor. The contractor/NPCA bid has strong support from the surrounding community and announcement of the winning bid is expected sometime this Spring.

• In March, hold the National Advocacy Days in a virtual format to lobby for Peace Corps with members of Congress.

• Continue to support evacuated RPCVs with job information, webinars and other necessary activities as needed

• Hole a virtual "Peace Corps Connect" conference in October for all NPCA members, RPCVs and interested parties in September

• Work with Peace Corps and Congress to Implement the recommendations for Peace Corps' future as outlined in the "Peace Corps Connect to the Future" report.

• Help Affiliate Groups to Thrive and Succeed.

• Amplify PC's Global Impact by funding projects and providing other international support.

• Increase NPCA's capacity and sustainability.
