

SEAPAX 2020 Annual Report

Dear SEAPAX Members,

2020 is a year we will not forget any time soon. It began with the emergence of COVID-19, a once in a century global pandemic. The pandemic forced us to cancel not only the Peace Corps Connect 2020 Conference that was going to take place in Seattle, and for which we were co-hosts, but also the majority of our in-person events. We also witnessed the evacuation of all serving PCVs, effectively shutting down the Peace Corps—a first in its nearly 60-year history. On top of all of this, the killing of George Floyd, following a way too long list of unnecessary killings of Black individuals, ignited national protests calling for racial justice. The year ended with one of the most divisive and contentious presidential elections in modern U.S. history.

As difficult as this past year has been, I would like to thank you—the SEAPAX community—for all that you do. Your work and contributions have provided much needed support to our local RPCV and Seattle communities. Your actions and engagement have made a real difference.

In early 2020, we launched a Mentorship Program, and shortly thereafter, we witnessed an outpouring of support from members who rose to the call and volunteered their time to assist those who were looking for some sort of guidance. A significant number of mentors were paired with individuals who had recently been evacuated from their Peace Corps service due to COVID-19.

A number of members also provided invaluable input on actions our Board could take to help our organization and its associated events become more inclusive to minority groups. We deeply appreciate your recommendations and we are better off because of them. The recommendations helped us decide to create a Diversity and Inclusion Chair position.

I would also like to give special recognition to our local RPCV community for its effort to help fight COVID-19. A collaboration between the National Peace Corps Association (NPCA) and SEAPAX members led to the creation of the NPCA Emergency Response Network (ERN). In its current form, the program is designed to organize teams of COVID-19 contact tracers, composed of RPCVs. The teams are contracted to work with public health organizations. As of early November last year, the pilot NPCA ERN contact tracer team is working with the Seattle and King County Department of Public Health.

None of this would have been made possible without the local effort of SEAPAX member, and new Board-member, John Berry, who is now the NPCA ERN Director. We owe tremendous gratitude to John for his vision, perseverance, and effort to help make our local communities a safer and healthier place. Because of his work and dedication, paid positions were created specifically for RPCVs during this difficult economic time (half of the pilot contact tracer team members were evacuated last year). I would also like to thank all those who stepped up to become contact tracers. Your work is critical for improving and maintaining the well-being of our communities.

These are just several examples of how our community came together and responded to a specific challenge of 2020. To me, they reflect the true spirit of what it means to be a PCV, not just for a two-year period, but rather over a lifetime. A large part of our identity is helping individuals and communities in need, whether abroad or domestically. Your contributions are truly inspiring and uplifting.

We hope that you will continue to keep up the good work in 2021, and remain being the supportive community that you are. Unfortunately, we have not been able to host many of our normal activities (i.e., in-person social events) due to COVID-19, but we remain optimistic that we will be able to resume "normal" operations sometime during the second half of 2021. Until then, we will continue to explore alternative options for connecting and sustaining our vibrant SEAPAX network.


SEAPAX is a group of former Peace Corps volunteers whose mission is to support, connect, and engage Returned Peace Corps Volunteers (RPCVs) in the greater Seattle area. We do so by supporting RPCVS' transition back to life in the United States through social, professional, and service opportunities, while also offering a forum for communication and connection. We are dedicated to improving international understanding at all levels, drawing on the lessons we have learned from living in the countries where we once served to promote awareness of the social, political, and economic circumstances, as well as the global interdependence, of people worldwide. This dedication stems from our aim to fulfill the Third Goal of the Peace Corps: help promote a better understanding of other peoples on the part of Americans. SEAPAX also provides opportunities to advocate for Peace Corps and supports community-based local and international organizations in the form of small grants and contributions.



In addition to the Seattle group, there are several informal satellite RPCV groups in other cities, which are part of the SEAPAX network. In the Bellingham area, Cat McIntyre coordinates social and service opportunities for RPCVs. Events are publicized through the SEAPAX website, social networks, and newsletter. The groups in Everett, Olympia, the Kitsap Peninsula, and Wenatchee hold activities periodically, which are also publicized by SEAPAX.

Governance

SEAPAX is run by a volunteer Board of Directors. This includes annually elected Officers and Directors-At-Large who serve one year terms, which run from January 1st through December 31st. Elected board members have board-voting rights and appoint non-elected Directors (i.e., Chairs and Coordinators) to help oversee specific programs and activities.

Peace Corps Connect 2020

Unfortunately, due to the Covid-19 pandemic, NPCA and SEAPAX decided to cancel the Peace Corps Connect 2020 conference, which was scheduled to take place in Seattle in July. The decision, made in April, was not taken lightly, and it was made in accordance with CDC and WHO guidance for public health and safety. SEAPAX inquired if it would be possible to host the 2021 conference instead, but it had already been determined that the 2021 conference, being the 60th Anniversary of the Peace Corps, would be held in Washington, D.C.

Mentorship Program

On March 28th, SEAPAX launched a new mentorship program aimed at connecting RPCVs to resources in the following areas:

- Finding housing
- Job/career/professional development
- Social networking events
- Reintegration and readjustment
- Graduate school
- Service/volunteer opportunities
- Navigating Seattle
- Talking about the Peace Corps experience

The program was an immediate success, with fifteen mentee applicants immediately following the launch. Mentors were initially recruited by Board members, but many other SEAPAX members stepped forward after the program launch. Overall, 29 mentors served 50 mentees throughout 2020.

Diversity, Equity, and Inclusion

The SEAPAX Board released a statement on June 6 in support of Black members of our Peace Corps community to affirm that Black Lives Matter, recognize past and present harm, and create awareness around areas of complacency in our community.


A group of SEAPAX Board members met on June 13 to begin a conversation around racial justice, privilege awareness, and awareness of colonialist legacies, along with current forms of imperialism. A working group then convened and generated a list of suggestions for the Board , including the creation of a Diversity and Inclusion Chair. Megyn Rodriguez became our Acting Chair in July, and was formally appointed in November, and set forth to create a Diversity and Inclusion Committee. This committee is active in discussing which topics to bring to the Board, suggestions for Board and SEAPAX member action, and the role and trajectory of the Chair and committee moving forward.

SEAPAX International Book Club

The Book Club discusses books with themes and authors with an international focus. It meets every two months on Sunday afternoon at rotating locations. Coordinated by Darien Luce, meetings are held at coffee shops and other locations around the city. Due to Covid-19 restrictions, some meetings after March 16 were held via Zoom. All interested parties, whether or not they have read the book, are welcomed.

Advocacy

Beth Ahlstrom, Erin Branigan and Carlie Sulpizio stayed apprised of NPCA legislation by participating in bi-weekly NPCA advocacy Town Hall meetings throughout the year, as well as the annual summit in October, done virtually. Carlie left the team in November to work overseas, and new team members Jerome Siangco and Kenney Tran came on board.

Before Covid-19 precautions were put in place, Erin represented SEAPAX and participated in the NPCA Day of Action on the Hill on March 5, 2020. The Washington State delegation, including Jerome Siangco, visited Senators Cantwell and Murray and Representatives Jayapal, Smith, Heck, and McMorris-Rogers.

In part due to the pandemic and worldwide evacuation of PCVs in mid-March, 2020 ended up being a busy year for NPCA legislation. Major initiatives included the financial and health needs for evacuees (extension of health insurance, access to unemployment funds, etc.,) and adequate (level) funding for PC as the agency prepared for the re-deployment of Volunteers. The team successfully gained co-sponsorship of Peace Corps legislation by 6 legislators (K. Schrier, A. Smith, D. Heck, D. Kilmer, R. Larson, and P. Jayapal), and the SEAPAX president wrote to Senators Cantwell and Murray requesting their support for level funding of PC's fiscal year '21 budget. The team sent Peace Corps calendars and thank you notes to the WA delegation, thanking them for their continued support of PC.

In addition to March's in-person meetings, the team organized two virtual meetings with local congressional staffers for Congresswoman Jayapal and Congressman Smith and participated in another with Senator Cantwell's staff as part of a cross-state collaboration with Eastern Washington's RPCV group in support of Peace Corps funding and reestablishment of overseas operations.

More visibly, Erin worked with Jerome to compose a Letter to the Editor, published in the Seattle Times: <u>Peace Corps: Missions interrupted</u>. Beth also obtained sponsorship funds for the Peace Corps Connect Conference from Pacific Lutheran University. The team maximized use of the SEAPAX newsletter and Facebook private group to encourage area RPCVs to contact their elected representatives.

SEAPAX is open to all RPCVs and friends. Our membership, numbering more than 1300, represents volunteer service in an astonishing 109 countries, from Afghanistan to Zimbabwe, and ranging from the first year of Peace Corps in 1961 to those evacuated in 2020. In 2016, we moved to a dues-free membership model. We made this change in concert with a similar transition by NPCA, to promote a broader, more diverse, and more inclusive community. But we still depend on donations to fund our events and advocacy work as well as to cover website and newsletter costs. We suggest a \$15 annual contribution, but any level of support is welcome. Grants

Financial Activity

501(c)(3) Status

In June, SEAPAX was officially registered as a 501(c)(3) Charitable Nonprofit. Beginning April 20, 2020, depending on your filing status, individuals may be able to deduct their contributions to SEAPAX when they file their federal income taxes.

Guest Presentations - Board Meetings

SEAPAX hosted two presentations following open Board meetings. Pangea Giving presented after the January meeting, and Antioch University presented on their graduate programs following the March meeting. Members were informed of these presentations in the monthly newsletter.

Public Health – Seattle & King County (PHSKC) Contact Tracers

In late summer, we helped recruit a 9-person team of COVID-19 contact tracers. The team, composed entirely of SEAPAX members, became the inaugural group of the NPCA Emergency Response Network (ERN), contracted to work with PHSKC.

The effort to organize a local RPCV response to COVID-19 has both local and national origins. John Berry, a SEAPAX member and a new 2021 Board-member, began working on a local effort to combat COVID-19 almost as early as the first reported case in Seattle. He soon connected with NPCA, leading to the creation of NPCA ERN, with John serving as its Director.

The inaugural group of contact tracers continues today to work with PHSKC. Efforts are ongoing to establish additional teams of contact tracers.

We would like to give a special thanks to John Berry and those who joined the first cohort of NPCA contact tracers.

Look Ahead to 2021

In accordance with CDC and Washington DSHS Covid-19 public health and safety protocols, SEAPAX continues to suspend in person events. We will monitor the situation, follow public health guidelines, and host online and outdoor events as deemed appropriate.
